Govind Ramnath Kare College of Law was established in the year 1979 when acute need was felt to enable aspirants from South Goa to pursue legal education without having to travel to far away for the same. Initially the institution was affiliated to the Bombay University until the birth of the Goa University, to which it is affiliated

today. What started off in a rental premises in a humble way in Borda-Margao has today grown into an independent multi-storeyed building which is well-equipped in terms of infrastructure, library facilities etc. and a well-qualified and competent faculty. This makes the institution



the only Centre for Legal Studies in South Goa, which is recognized by the University Grants Commission (UGC) under Secs. 2(f) and 12(b) and the Bar Council of India for imparting professional education in law and is today accredited by NAAC with a B Grade (CGPA 2.63 on a 4.0 point scale). Looking back at its glory, the institution boasts of several gold medalists at the University examinations, well-placed corporate employees, high ranking officials in the bureaucracy and several judicial officers including the first Goan woman judge of Bombay High Court.

PROCEDURE FOR PLACEMENT PROGRAMME

RECRUITERS' REGISTRATION:

Interested recruiters are requested to confirm via email about participation in the placement programme to the placement committee, G.R. Kare College of Law (placements.grkcl@vvm.edu.in) on or before 30th November 2015. After confirmation, a detailed firm profile form will be sent.

STUDENTS' REGISTRATION:

Student registration desks will be opened after the Firm Profiles are displayed in college.

Interested students will be required to fill a Student's Registration Form and submit it to the Placement Committee with their resumes.

The CV collection shall be undertaken and the same will then be forwarded to the Recruiters by 5th February 2016

The Interviews shall take place on 27th February 2016. The list of the candidates selected should be informed on the same day.

All communication must be through the Placement Committee. Recruiters must not, in any case, communicate any offers directly to the candidates.

After selection, the recruiters are requested to issue offer letters to the candidates without delay and preferably before 10th March 2016.

RECRUITMENT PROCESS:

Recruiters may, in accordance with their own policy, conduct a Recruitment Process of their preference: On-Campus Interviews, Off-Campus Interviews, Group Discussions, and Written Tests etc.

Recruiters shall, as far as possible, adhere to the process mentioned by them in their Recruitment Registration Form. Any change in the Recruitment Process of the Recruiter must be communicated to the Placement Committee well in advance.

The selected candidates who feature on more than one Recruiters List will be given the liberty of accepting the offer of their choice. In the event of a Selected Student not joining a Recruiter, for any reason whatsoever, the candidates on the waiting list will be elevated. This will be done according to the order of preference given by the recruiters. The final decision of the candidates will thereafter be intimated to the Recruiters
