ABOUT THE COLLEGE

Govind Ramnath Kare College of Law, the only Centre for Legal Studies in South Goa, was established in the year 1979 when acute need was felt to enable aspirants from South Goa to pursue legal education. Initially the institution was affiliated to the Bombay University until the birth of the Goa University, to which it is affiliated today. It is recognized by the University Grants Commission (UGC) under Secs. 2(f) and 12(b) and the Bar Council of India for imparting professional education in Law and is today accredited by NAAC with a B Grade (CGPA 2.63 on a 4.0 point scale). Looking back at its glory, the institution boasts of its alumni being gold medalists at the University examinations, well-placed corporate employees, high ranking officials in the bureaucracy and several judicial officers including the only two women Judges of Bombay High Court, hailing from the State of Goa.

The institution has state-of-the-art infrastructure and is located in a scenic environment, away from the hustle and bustle of the city, thereby providing a conducive environment for learning. It offers two under graduate programmes, viz. 5 year B.A.LL.B. and 3 year LL.B. programme as well as a 2 year LL.M. programme. The Ph.D. programme will be offered in the coming academic year with the commencement of the Research Centre.

CONCEPT NOTE AND OBJECTIVES OF THE SEMINAR

Crime and Criminal Justice are vast and fascinating issues that highlight the complexity of defining and solving social problems. Crime and society are very closely inter-linked. One important aspect of criminal law is victimisation of vulnerable groups, particularly through the use of cyber space and the other important aspect is irregularities in criminal justice administration.

Therefore it is of imperative concern of academicians, research scholars, law makers and law enforcing mechanisms in particular and of the members of society in general to understand these issues and all related concerns of criminal law.

The present seminar shall focus on such aspects of criminal law and help in providing a research based platform for brainstorming and providing ways and means for amelioration.

CALL FOR PAPERS

Papers are invited for presentation in the seminar in any of the following sub themes:

Vulnerability and victimization in criminal law

- Victim support in criminal law
- Conventional and Innovative criminal justice responses
- Pitfalls and misuse of enactments meant for protection against atrocities, dowry, domestic violence, sexual harassment, etc.
- Hostility of systems towards persons involved in victim assistance
- Judicial approach to victim compensation
- Victimisation of the accused and witnesses in criminal justice administration

Revisiting criminal laws due to challenges from new forms of victimization in cyber space

- Response of criminal laws to male victims of cyber crimes
- Restorative Justice and therapeutic Jurisprudence
- Cyber violence against women & children
- Changes in IT Act, 2000 and its impact on cyber victimization
- Lack of mechanisms to investigate cyber- related offences
- Prevalence and economic impact of cyber crimes

Deficiencies, irregularities and extraneous considerations in criminal justice administration

- Judiciary and media
- Procedural lacunae in criminal investigations
- Investigative negligence
- Political interference in matters of trial
- Special treatment accorded in trial of influential offenders
- Disparity and discrimination in sentencing

Peer reviewed articles shall be embodied in the special issue on Criminal Law of **KARE LAW JOURNAL** with ISSN No., an annual publication.

GUIDELINES FOR ARTICLE WRITING

- An article must be an original work of the author(s) and no part of the article shall be copied or lifted from any single source. Article contributors are solely responsible for any issues arising out of plagiarism and neither the Editorial Board of Kare Law Journal nor G.R. Kare College of Law, Margao-Goa will be liable for the same.
- An article shall be in double line spacing, font size 12, Times New Roman, inclusive of footnotes and any other explanations, by adopting MLA citation style and shall ordinarily not exceed 8000 words. Use margins of 1.50 inches on the left and 1.00 inch on all other sides. The article shall be accompanied by submission of an abstract of 300 words and about five Keywords.
- Selection of articles will be done through peer review by the Editorial Board and the decision of the Board is final and binding.
- Articles which are selected shall be the copyright of the G. R. Kare College of Law, Margao-Goa. Articles that are under consideration by other journals shall not be considered for publication.
- The author(s) shall be consulted prior to publication, if the Editorial Board desires to make any substantial changes to any article.
- Articles submitted and not selected for publication will be returned to the author(s).
