



All the students are satisfied with the syllabus as it contains modern and advanced topics and it also gives them the understanding of the basics of the course and is evenly balanced on various topics.




Majority of the students are satisfied with the organization of the courses, while a few are of the view that the courses need to be revised as there are too many topics with no clear connection between them.


Majority of the students are of the view that the courses are relevant for their future career and development, while a few are of the view that the content covered by the courses was too large to be covered in the respective semester.


The library is full of informative books which helped me to enhance my knowledge on the practical concept of law.

Also need more visiting lecturers who are specialists in their field.




17. Kindly offer your valuable comments on the adequacy of the content of the courses and structure of the curriculum in the space given below:

The theory content learnt and taught is superbly important to establish a strong foundation however, when we venture into the field it's more of technicalities. Exposure of the students to the field and it's technicalities at an early stage is vital from my own experience.

While the curriculum is comprehensive as it is, students could benefit From studying the laws governing Proceedings peculiar to the State of Goa. this may include studying The Goa Succession, Special Notaries and. Inventory Proceeding Act, 2012 as well as practical application of land laws. The content of the course is good

Students must be encouraged to be updated on the latest perspectives on laws with respect to case laws and current affairs across the nation and to analyse the effects of the cases on various social and legal dimensions. The courses must not be limited to the content of law but must extend to enabling students to analyse, dissect, rebut and opine about the law, the cases and all its dimensions. The importance of internships cannot be stressed enough. Students must be compulsorily required to undertake internships right from the first year itself, whether it be with NGOs, legal magazines, lawyer's or judges chambers or law firms. Students must be encouraged to look beyond the state. Moot-courting must be actively encouraged. The curriculum itself must be re-examined and updated and emphasis must also be given to practical elements simultaneously with legal theory. Classes should be interactive, and deliberative and utilise ICT in addition to traditional lecture-based teaching.


There needs to be a perfect balance between the theory and practical aspect of law which is somehow missing in the current course structure. Also, the course should include more of Goan laws (For eg: The Portuguese civil code) keeping in mind the use of those legislations during the legal practice. Apart from that, the institution needs to make internship compulsory right from the 1st semester and also help students get internships in case of difficulty in getting the same. With regards to the e-learning is concerned, the college needs to sign up to sites like Manupatra, SCC online, Hein online etc. and should make it easily accessible to the students for better learning and researching skills.














