

'THE CODIFICATION AND PROGRESSIVE DEVELOPMENT OF THE LAW OF THE SEA'

The International Law Society of VVM's G. R. Kare College of Law, in collaboration with its MoU partner, Faculty of Law, University of Lisbon, Portugal, and Lisbon Public Law Research Centre, Portugal organized a GRK masterclass on the topic "Codification and Progressive Development of the Law of the Sea" on 2nd February 2024 in the Smart Class. The resource person for the Masterclass was Prof. Dr. Fernando Loureiro Bastos, Professor, Faculty of Law University of Lisbon, Portugal. The GRK Masterclass commenced at 10:00 am with Ms. Franskina Gama, a student of the institution, welcoming the audience and introducing the resource person.



During the session, Dr. Bastos delved into essential aspects of maritime law, highlighting the progressive development of the law of the Sea.

Following Prof. Bastos's session, there was a question and answer session. This was followed by an address by Principal Dr. Maria Goretti Simoes who in her address, discussed the significance of the field of international law Prof. Dr. Ana Rita Gil from the Faculty of Law, University of Lisbon, Portugal, was also present for the session. During her address, Professor Gil delved into various facets of migration and human rights, shedding light on real-life cases to illustrate the challenges. The National IP Yatra in the form of a two day workshop was conducted by ASSOCHAM along with its ASSOCHAM IP Facilitation Centre and in association with MSME. It was held at Hotel Fortune Miramar on the 8th and 9th of February, 2024 from 10:00am to 4:30pm. Asst. Prof. Merville Rodrigues being incharge of IPR Cell of the College and Asst. PRISON VISIT TO 'CENTRAL JAIL COLVALE'

15th, 17th, 19th & 21st February 2024



The Criminal Law Club of G.R. Kare College of Law, Margao, conducted a visit to the Modern Jail, Colvale. The students of the Third year Degree Course and the Fourth year B.A.LL.B. Course got an opportunity to visit the Modern Jail, Colvalem as scheduled permissions for the same were obtained from the Inspector General of Prison, Panjim. The visit was divided in 4 batches of students comprising of total 102 students accompanied by 12 faculty members divided in 3 on each day of visit. The visit was scheduled for the 15th, 17th, 19th and 21st of February 2024.

On the 1st day i.e on 15th February 2024 of the visit, 23 students of the Third year Degree were scheduled for the visit. The students were accompanied by Asst Prof. Yamini Dalvi, Asst Prof. Lariza Gomes and Asst Prof. Isha Rajadhyax. The departure from the college premises was at 12.45 p.m. and the arrival at the Jail premises was by 2.30 p.m. Upon completion of all formalities, the students were accompanied by Asst. Jailor, Mr. Lotlikar inside the Jail Premises. The students were given a tour of the entire jail facility, which included the hospital housed within the jail, the legal aid center, library, IGNOU study center, various blocks for under-trial and convicted men, separate block for women, kitchen, workshops etc.

The second visit was made on the 17th February where the students of the T.Y.LL.B Degree were accompanied by the Faculties Asst. Prof. Ruby Luis and Asst. Prof. Afshan Bi. As we reached the premises we conducted a look at all the blocks and was accompanied by Mr. Ramnath Gaude who was the Asst. Jailor.

The third visit was made on the 19th February where the students of the Fourth year B.A.LL.B were accompanied by the Faculties Asst. Prof. Sapresh Devidas and Asst. Prof. Akanksha Gehlaut and Asst. Prof. Apurva Prabhudessai. As we reached the premises we conducted a detailed tour of all the blocks and was accompanied by Mr. Gaonkar who was the Asst. Jailor.

The fourth visit was scheduled on 21/02/2024 at 3 p.m. to 4.30 p.m. comprising of 26 students each accompanied by 3 faculty members namely Harshad Bandodkar, Pooja Naik Gaonkar and Niharika Chari on day of visit. The departure from the college premises was at 12.45 p.m. and we reached the Jail premises by 2.30 p.m. and returned back around 5.45 p.m.

On completion of all the formalities Mr. Chodankar, Asst. Jailor took us to the Jail premises. We visited all the blocks in which the inmates were present. The blocks were that of the kitchen, hospital, under-trial and convicts block. The other blocks visited were that of NDPS-under trials, under trials and convicts. There was a separate block for women as well. There was also a library comprising of various books for the inmates. There after we were taken to the factory block comprising of carpentry, tailoring, candle making, paper bag making etc. There were 64 male inmates and 34 female inmates.

During all the visit the students experienced the influence of reformative form of punishment.

The Prison Authorities answered all the questions of the students. The visit was very informative and the students learned a lot about prison administration.
