Hon'ble Justice Shri Shriram Madhusudan Modak, Judge, HC of Bombay at Goa was the Chief Guest and Keynote speaker on the ocassion. Mr. Nitin Kunkolienker, President and Chairman of Governing Council, VVM, Adv. Pritam Morais, First Vice President and Co- Chairman of Governing Council, VVM, Adv. Prasad Naik, Member of Governing Council, VVM, Adv. Sanjit Dessai were present at the ocassion.

Mr. Nitin Kunkolienker, President of VVM delivered welcome address through virtual mode. Adv. Pritam Moraies, First Vice President and Co- Chairman of Governing Council of VVM introduced the keynote speaker to the audience. Hon'ble Justice Shri Shriram Madhusudan Modak, Judge, High Court of Bombay delivered talk on the topic 'Broad aspects of the Bharatiya Sakshya Adhiniyam, 2023 through virtual mode. Bharatiya Sakshya Adhiniyam, formerly known as Indian Evidence Act is an inseperable part of court trials. The speaker took the audience down the lane when the amendment Bills attracted lot of controversies on various platforms. The law enforcement agencies have the primary authority to sensitize citizens about various aspects of amended laws. The speaker highlighted important amendments made in Bharatiya Sakshya Adhiniyam 2023. Provisions regarding extra territorial operation of law, recording of digital evidence, production of electronic records as evidence, confession are some of the provisions which ought to attract the attention of students and practitioners of law. The speaker shared the experience of series of Bombay Bomb blasts and the relevance of case trial in light of provisions of Indian Evidence Act. The speaker also highlighted the judicial outlook and important judgments pertaining to electronic records and electronic evidence. Assistant Professor Ms. Lariza Gomes compered the program.



WINNERS AT CONSTITUTIONAL LAW DRAFTING COMPETITION

02 March 2024

GRKCL team comprising of Ms. Komal Bandekar, Ms. Yasmeena Fernandes, Mr. Brendon Fernandes, Ms. Roshan Fernandes, and Mr. Aloysius Caeiro won 1st prize and emerged victorious in the Constitution drafting competition organized by the Central Bureau of Communication, Ministry of Information and Broadcasting, Government of India, Field Office Panaji, associated with the Regional Office, Pune. They were guided by HoD Dr. Shruti Nadkarni and Asst. Professor Yamini Dalvi (In charge Constitutional law club)

The competition, held on February 29, 2024, in Panaji, tasked participants with drafting a constitution for Gafuropia, a fictional island nation established by climate refugees. The draft submitted by the team for the Constitution of the Republic of Gafuropia was a meticulously crafted document.



One of the notable features of the draft was its emphasis on innovation and sustainability. The establishment of a National Innovation Fund reflected the nation's dedication to fostering research and development in sustainable technologies and practices. This fund ensured financial support, research grants, technology incubation, capacity building, collaborative partnerships, commercialization support, and monitoring and evaluation, thereby promoting a culture of innovation and environmental responsibility. The draft submitted by the team demonstrated a thorough understanding of constitutional principles and legal terminology while addressing the unique challenges faced by Gafuropia. It lays the groundwork for a progressive and sustainable nation, guided by the principles of democracy, justice, and environmental stewardship. The team defeated its competitors and were declared winners.
