

Participation in 3rd V.S. Mallar Memorial Legal Aid Competition

15 November 2024



VVM's G. R Kare College of Law, Margao Goa participated in 3rd V.S. Mallar Memorial Legal Aid Competition 2024. The competition provided the Legal Aid Society the opportunity to extend and expand its wings to spread literacy and promote awareness of legal aid in novel and innovative ways. As participant of this Competition the members of Legal Aid Society collectively engaged themselves in the planning, execution and conduct of the six core deliverables namely, Speed Mentoring, Legal Podcast and FAQ Drafting, Street Play, Jan Sunwaii, Reel Making and Legal Assistance Lab.

This creative campaign inspired and infused the participants with the vigor of enthusiastic legal activism. Beneficial community engagement helped sensitize the participants, allowed them the ground to unleash their creative side to promote social responsibility and raise legal awareness, provided them ample scope to understand the spirit of the Constitutional mandate on Legal Aid and Legal Services and theprofessional commitment associated with advocacy.

Speed mentoring awareness sessions were conducted in High Schools and Higher Secondary Schools in the different Talukas of the State of Goa especially on the theme of Child Safety and the POCSO Act, which was the theme of the Legal Aid Society, including other topics of socio-legal relevance. A total of 19 speed mentoring sessions were held by the various Legal Aid Cells under the guidance of the Legal Aid Cell, Faculty In-charge.

Street plays and Skits were performed in English and regional languages namely, Konkani and Hindi and were carried out at strategic locations to garner maximum reach out of the public on socio-legal topics affecting day to day life, such as Menstrual Hygiene, Child Safety and Road Safety, Consumer Protection, Waste Management etc. A total of 18 Streets Play were performed.

Reel Making component aimed to engage youth in promoting legal awareness and literacy in digital mode through creative short reels on socio-legal issues. Legal Aid Society, through its Legal Aid Cells, contributed 27 reels. These reels highlighted topics such as the Right to Education, Child and Juvenile Rights, and Rights of Elderly Citizens, emphasizing the commitment to enhancing legal literacy and social justice.

A series of Jan Sunwaiis were majorly held in rural areas and also within the jurisdiction of the Municipal Corporation of Margao with the support of Legal Experts, NGOs, Panchayats, Clergy and DLSA. This initiative provided us the opportunity to hear and address issues concerning children, women, maintenance, senior citizens, environment and property analyzed by various stakeholders and suggestions for reducing punishment in consensual POCSO cases, a call for balanced Justice is being worked on.

Legal Podcast promote legal awareness, share insights, analyze trends and explore complex issues thereby ensuring reach through the medium of social media to stay informed and adaptable to ever-evolving legal landscape. Three episodes of Legal Podcast were held Women and Child , Understanding Legal Aid and Free Legal Services in India and Consumer with guest experts in the relevant field. The Legal Assistance Lab/Legal Litigation Lab offered us the opportunity to provide legal assistance to the general public. Informative sessions were held in rural and remote areas with the aim to educate the public especially the marginalized segments, where legal resources are limited, about rights and legal options and the methods of dispute resolution and mechanism. Services in the nature of consultation, case evaluation, necessary representation and support to the needy were provided. This enabled the aggrieved to navigate the legal processes such as filing applications, applying for schemes or any other public benefits thereby ensuring access to legal representation and justice. The student volunteers also conducted surveys and based on the survey, along with the assistance of Department of Social Welfare assisted in the documentation process of senior citizens cards. Awareness videos created on rights of senior citizens were disseminated through the medium of social media platforms of the institution. Sakhi One Stop Centre is a scheme of Ministry of Women and Child Development, the student volunteers assist at the Sakhi OSC South Goa in promoting awareness on rights of women and children through legal awareness camps and street plays in various Talukas in South-Goa and also assist the documentation and filing process.

TWO-DAY HANDS-ON TRAINING WORKSHOP

14, 15 November 2024





The TLET Cell of VVM's Govind Ramnath Kare College of Law, Margao Goa organized a two-day workshop on "Optimal Device Utilization and Basics of Canva." The event aimed to enhance the digital literacy and design proficiency of participants, focusing on optimizing device performance and learning Canva, a versatile graphic design tool. This hands-on workshop was attended by faculty members of G.R. Kare College of Law, who actively participated in the interactive sessions.

The workshop spanned two days, with each session designed to balance theoretical learning and practical application.

Session for Day 1 of the workshop was titled on System Performance Optimization and Productivity Tools. The Resource Persons for the session was Mr. Akshay Chari, System Administrator, GRKCL.

This session focused on enhancing device performance to support seamless digital workflows. Key topics covered were System Performance Optimization where participants learned about techniques to boost device performance, including storage management, minimizing background tasks, and optimizing system settings. Productivity Tool where faculty members were introduced to advanced shortcuts and operating system tools to streamline their work processes. Data Management and Security which emphasized on file organization, secure backups, and troubleshooting common device issues to prevent disruptions. Various activities and engagement exercised were conducted for the session where faculty members brought their laptops for hands-on exercises, where they implemented the optimization techniques in real time. The interactive Q&A sessions encouraged participants to share their experiences and seek personalized solutions.

Session for Day 2 of the workshop was titled on canva basics and advanced Design Techniques The resource person for the session was Mr. Ramkrishna Reddy, Assistant Professor, SDCCE.

The second session introduced the participants with various Canva tools and features, emphasizing their application in professional and academic settings. The resource person highlighted on the Canva interface and essential tools for creating impactful designs. Faculty members learned about fundamental design elements like color theory, typography, and layout to create visually balanced content. The session covered branding tools, animations, and team collaboration features for efficient project management. Participants created their own designs, such as posters, social media graphics, and presentation slides, under expert guidance. The collaborative nature of the session allowed for peer feedback and creative exchanges.

The workshop saw enthusiastic participation from faculty members of G.R. Kare College of Law. Their active engagement demonstrated a keen interest in leveraging technology for academic and professional purposes. VVM's Govind Ramnath Kare College of Law, in collaboration with the Election Commission of India and the Directorate of Higher Education (DHE), Goa, organized a special 'Electoral Roll Enrolment Camp' on 22nd November 2024. This initiative aimed to promote voter awareness and facilitate enrolment of eligible students as voters.

The primary goal of the camp was to encourage young voters to exercise their democratic rights and ensure their inclusion in the electoral roll. The initiative reflects the commitment of the college to civic engagement and active citizenship.

The camp was conducted with the support of the Assistant Electoral Registration Officer (AERO) for the 31, Margao Assembly Constituency (AC). To ensure the program's smooth functioning, 7 Booth Level Officers (BLOs) were deputed to assist in the enrolment process.





