Subject: Timeline for Admission to B.A. LL.B. Programme -Academic Year 2026–27.

Sir/Madam,

The Directorate of Higher Education (DHE), Goa, hereby notifies the detailed schedule and procedural framework for the admission to the **B.A. LL.B. Programme** for the academic year **2026–27**.

1. Online Application Process:

DHE will invite and collect online applications for the B.A. LL.B. programme from **2nd April 2026 to 13th April 2026 (midnight)** through the designated portal.

2. Entrance Examination (GU-CLAT):

- o Goa University will issue hall tickets based on completed applications and fee payment verification as on **13th April 2026**.
- o The GU-CLAT examination is scheduled on **22nd April 2026** and shall be conducted by Goa University.
- o The results of **GU-CLAT** will be declared by **24th April 2026**.

3. Sharing of Applications:

DHE will share the submitted applications with both colleges. Based on these:

- o Colleges can initiate document scrutiny and preliminary preparation of merit lists, considering 50% weightage of XII standard marks.

4. Final Merit Preparation:

- o Goa University will share **GU-CLAT** results at the earliest, tentatively by **25th April 2026**.
- o Both colleges shall independently prepare merit lists strictly in accordance with the criteria prescribed by Goa University.
- o Subsequently, both colleges shall **cross-verify the merit lists** and finalize the same.

5. Submission and Publication of Merit List:


- The final merit list, duly signed by the respective Principals, shall be submitted to DHE **on or before 5th May 2026 (same day)**.
- The results shall be published simultaneously on the respective college portals and the DHE portal.

6. Admission Counselling:

- Admission counselling will be conducted on **11th, 12th, and 13th May 2026**.
- The venue for counselling will be **V.M. Salgaocar College of Law campus**.
