[A relaxation of 5% shall be provided for the SC/ST/OBC(Non-creamy layer)/Differently-abled (physically and visually differently-abled) categories]
- (ii) Clearance at the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SET. However, candidates who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, as incorporated in the relevant Goa University Ordinances, shall be exempt from the requirement of the minimum eligibility condition of NET/SET for appointment.

In the case of posts at Sr. Nos. 1 and 2 above, in the event of non-availability of suitable qualified candidates from the mentioned reserved categories, the vacancies shall be filled in temporarily, by the candidates belonging to General Category on contract basis, purely as a stop-gap arrangement.

In the case of posts at Sr. No. 3 above, in the event of non-availability of suitable qualified candidates from the mentioned reserved categories, the vacancies shall be filled in by the candidates belonging to General Category and in the event of non-availability of candidates fulfilling ESSENTIAL QUALIFICATIONS (ii), candidates fulfilling ESSENTIAL QUALIFICATIONS (i) may be considered for appointment.
